# International Day of Action for the release of Mansur Osanlu and Mahmud Salehi from the notorious prisons of Islamic Republic of Iran

International Trade Union Confederation (ITUC) and International Transport Workers' Federation (ITF) released a joint statement yesterday, July 24, 2007, expressing their demand for the release of imprisoned worker activists Mansur Osanlu and Mahmud Salehi in Iran. The statement determines August 9 as both a deadline for the Islamic regime to release the two activists and proposes it as an International Day of Action by ITUC and ITF affiliates as well as Global Union Federations, if their demand will not have been met in full by the set date. It calls for "urgent and determined action" and cites "the successful Action Day on 15 February 2006" (the international solidarity day with Tehran Bus Workers' strike last year). In yesterday's joint statement, ITUC and ITF request their affiliates around the world to hold different forms of protest action on August 9, starting with visiting the Iranian diplomatic mission in their country "with protest letters and/or hard copies of petitions collected by the ITF." The said statement is attached in full below.

Worker-communist Party of Iran (WPI) strongly supports the proposed international action for the release of Mansur Osanlu and Mahmud Salehi.

Just as WPI's branches in different countries took active part in 15 February 2006 International Action Day, this year too they will participate as best as they can, in co-ordination with trade unions, in 9 August Day of Action.

WPI ceaselessly exposes the crimes of the Islamic regime in Iran against both the workers as well as the people at large, and struggles for the immediate and unconditional release of all political prisoners in Iran, including Mahmud Salehi and Mansur Osanlu.

## Let's protest against medieval orders of lashes

Workers! Freedom Lovers!

Today, August 4th, 2007, 11 workers who were arrested in the events of May First in Sanandaj heard their verdicts. Based on these orders Khaled Savari, Eghbal Latifi, Yadollah Moradi, Tayeb Malayi, Fars Govilian, Sadigh Amjadi, Habibollah Kani, Moheyoddin Raiabi, Taveb Chatani, Sadigh Sobhani and Abbas Andaryari, each will spend 91 days in the jail and receive 10 strikes of lashes.

Issuing such orders for workers arrested at the events of May Day, while the whole world is protesting against detainment of Mahmood Salehi and Mansoor Osanlo, is a blow to the faces of millions of workers around the world who are asking the freedom of these two individuals and are decided to put an end to persecution, arrest and

detainment of workers' leaders.

For workers whose share from the wealth of the society is nothing but poverty and endless misery, such situations, such medieval orders and imprisonments only tell one thing: This is slavery and it is being imposed to the workers by the Iranian capitalism.

Barbaric repression of the workers with pepper gas, beating them with sticks and throwing them into prison for 10 days was not enough for these enemies of worker's class. They are planning to execute medieval orders of lashes and imprisonment, put chains around the neck of the wealth-producing workers and make us revisit the slavery era.

Workers! Freedom Lovers! We should not accept this situation. We should not let Mahmood and Mansoor remain in prison and orders concerning those 11 workers of Sanandaj being executed. Sanandaj's workers and their families have been living under the poverty line for all these years, suffering from expulsion *Continues P. 3*

From page 4 mented an unofficial marshal law against students of Tehran University and Polytechnique. 16 students are reported to have been arrested, including the following:

Mohammad Hashemi, Mehdi Arabshahi, Ali Nikonesbati, Bahareh Hedaiat, Hanif Yazdani, Ali Vefghi, Abdollah Momeni, Bahram Faiazi, Habib Hajheidari, Mojtaba Bayat, Saeed Hossein Nia, Masoud Habibi, Morteza Eslahchi and Ezzate Ghalandari.

- On the same day, more people were arrested in the capital Tehran, including a number of young motorists, whose families later gathered outside the police station where they were being held. A number of women's rights activists were also summoned to face various charges.

The above are just a few examples of the atrocities taking place in Iran right now. We call on all labour and human rights organisations around the world to protest in every way they can against this barbarity of the Islamic Republic regime to secure the release of Mansoor Ossanlou, Mahmoud Salehi and other activists, unconditionally and immediately, and to put an end to the executions, stonings and trial of workers, teachers and women's rights activists.

On behalf of the Worker-communist Party of Iran, I would like to express my sincere gratitude to you and the millions of members of your affiliated unions for your call for an international day of action for the release of Mansoor Ossanlou and Mahmoud Salehi. We strongly support your call for the August 9th day of action.

This is a crucial initiative, which comes in the wake of the February 15th action last year in support of the striking workers of Vahed Bus Company. While the Islamic regime in Iran has been conducting a massive wave of executions, stoning and arrest of labour, student and women's rights activists in the past few weeks, this action is not just another manifestation of workers' international unity and solidarity; it is not just an important step forward for workers in Iran. It is indeed solidarity with all the people in Iran in their confrontation with the Islamic regime; a regime which has no other means for survival but flogging, veiling, stoning, executing and imprisoning.

We shall actively take part in the August 9th action for the release Ossanlou and Salehi - just as our party did last year in the February 15th day of action both in Iran and in Europe, North America and Australia. This time too, along with the bus workers of Tehran, the workers of Saqez and Sanandaj and all workers throughout Iran who are fighting for the release of their jailed colleagues, as well as students and peo-

## To: International labour and human rights organisations

### Dear Friends,

The Islamic regime in Iran has launched a campaign of arrests, kidnapping, executions and stoning deaths in an attempt to drive back the ongoing protests, strikes and demonstrations in Iran by creating a climate of terror and fear. We are calling on all labour and human rights organisations around the world to raise their voice in protest against this barbarity of the Islamic regime.

The following are just a few examples of the Islamic regime's ongoing atrocities:

- On the evening of July 10th Mansoor Ossanlou, the president of the Union of Workers of Tehran and Suburbs Bus Company (Sherkat e Vahed), was abducted by the regime's plain clothes security agents as he was getting off the bus. He was beaten up and taken into custody. He is now being held at the high-security Evin Prison.

- Mahmoud Salehi, well known labour activist, long persecuted for organising May Day rallies and for his labour activities, and who has been in jail since April 2007, is reported to have slipped into a coma due to kidney failure following denial of medical care by the authorities. He lost his other kidney in previous years of imprisonment under the Islamic regime.
- On July 10th, workers arrested on May Day this year in the city of Sanandaj were put to trial on the charge of "disturbing the peace". They are: Khaled Savari, Eghbal Latifi, Yadollah Moradi, Taieb Molaee, Fars Gavilian, Sedigh Amjadi, Abbas Andaryari, Habibollah Kalkani, Moheiedin Rajabi, Taieb Chatani and Sedigh Sobhani.
- On July 14th, labour activists Shais Amani, the head of the executive board, and Sedigh Karimi, member of the board, of the Na-

tional Union of Dismissed and Unemployed Workers, appeared in court. Their charges include "disturbing the peace", "acting against national security", collecting donations for the family of Mahmoud Salehi, membership in their union and in a workers' committee working to set up free labour organisations, as well as "contacts with opposition organisations".

- On July 10th, the judiciary's spokesman announced that death sentences against 20 people had been upheld and a further 15 had been sentenced to death. It was also announced that around 100 people had been arrested in connection with the recent protests against petrol rationing.
- The stoning to death of a man in the city of Takestan was confirmed by the judiciary, following earlier denials.
